Therapeutic Recreation Professionals work with individuals of all ages who are experiencing disability, illness, or other limitations, teaching the skills, knowledge, and behaviors to live the best life possible.



Therapeutic Recreation is a process that utilizes treatment, education, and recreation participation to enable persons with physical, cognitive, emotional and/or social limitations to acquire and/or maintain the skills, knowledge and behaviors that will allow them to enjoy their leisure optimally & function independently with the least amount of assistance and participate as fully as possible in society. Therapeutic Recreation intervention is provided by trained professionals in clinical and /or community settings (TRO, 2003)

# Why Hire Registered TRO Professionals?



A Provincial Registration Designation for Therapeutic Recreation Professionals in Ontario

# An Individual Registered with TRO...

- Is currently practicing, supervising, educating or on leave from the field of Therapeutic Recreation (for a maximum of three years) OR is a recent graduate from a Therapeutic Recreation/Recreation/Leisure Services program.
- Holds an accepted direct or allied degree (R/TRO) or diploma (R/TRO DIP).
- Has successfully achieved the R/TRO or R/TRO DIP designation through TRO's voluntary registration (application) process.
- The registration (R/TRO or R/TRO DIP) designation is currently a voluntary credential that demonstrates a level of excellence. R/TRO is the designation for degree prepared practitioners and R/TRO DIP is for diploma prepared practitioners.



Therapeutic Recreation Ontario initiated the Registration process in 2003. Since then nearly 400 Therapeutic Recreation Professionals have successfully achieved the registration designation. To meet the growing needs of members, TRO has established the R/TRO DIP designation for diploma graduates effective September 2015.

# Therapeutic Recreation Process for Registration:

Members of Therapeutic Recreation Ontario have supported and sanctioned the development of a registration process for Therapeutic Recreation Professionals in Ontario.

The registration process differentiates members of TRO based on successfully meeting eligibility criteria based on:

- Formal Education
  Applies to relevant course work at a recognized post-secondary institution at both diploma and degree levels.
- Practical Experience
  Applies to a person holding a position that involves providing Therapeutic Recreation services.
- Professional Affiliations

The applicant must be a current member in good standing with Therapeutic Recreation Ontario.

• Professional Contributions

Applies to recognized activities that the applicant participates in, not only to continue one's own professional development, but also to actively support the development of TR as a profession.

### **Benefits to Employers**

The employment of a registered TRO professional helps to ensure that the client is receiving Therapeutic Recreation services from a professional that has achieved a level of excellence established by the provincial leaders in uniting and advancing the Therapeutic Recreation profession in Ontario.

### Registered TRO Professionals (R/TRO and R/TRO DIP):

- Meet minimum education criteria.
- Work within the TRO Standards of Practice and TRO Essential Competency Framework (ECF).
- Have extensive knowledge and skill-based training to enhance quality of care.
- Support an inter-professional approach to care.
- Have training and demonstrated abilities in core therapy skills including assessment, planning, implementation, documentation and evaluation.
- Have training in group-oriented processes to enhance cost effectiveness and efficiency in service delivery.
- Provide quality therapeutic interventions.
- Assess and manage risk management.
- · Possess diversified skills.
- Participate in ongoing professional development.
- Mentor and supervise Therapeutic Recreation students.
- Must complete the TRO Registration
   Maintenance process every five years,
   demonstrating ongoing professional
   development and current best practice.
